Purpose	<p>The Macca's Junior Sports Grants have been developed to provide junior sporting teams, junior sporting clubs, and junior sporting associations with equipment or funding to increase participation in a chosen sport.</p> <p>The Macca's Junior Sports Grants aim to increase participation in junior sports and encourage the habit of a healthy lifestyle amongst young Australians living in regional Western Australia.</p>
Application Period	<p>There are four (4) funding rounds. Applications may be submitted for each of the funding rounds as follows (in AWST/GMT +8):</p> <ul style="list-style-type: none"> (a) Round One: 9:00am 1 January to 11:59pm 31 March (b) Round Two: 9:00am 1 April to 11:59pm 30 June (c) Round Three: 9:00am 1 July to 11:59pm 30 September (d) Round Four: 9:00am 1 October to 11:59pm 31 December
Eligible Applicants	<p>You must be a registered group, organisation or association (Applicant) that organizes junior sporting activities or participates in junior sporting activities that also fits the below criteria:</p> <ul style="list-style-type: none"> (a) Applicant must be a not for profit organisation; and (b) Applicant must be located in, and the sport must operate within regional Western Australia; and (c) Applicant has not received a Macca's Junior Sport Grant within 9 months (i.e. 3 rounds) prior to current round
Application method	Eligible Applicants must, during the Application Period, fill in the form located at https://mcdonalds.com.au/juniorsportsgrants .
Judging	All eligible applications will be reviewed by an assessment panel at McDonald's Perth head office within two weeks after the end of each Application Period. The assessment panel will consist of one representative from McDonald's Australia Limited, and two other representatives nominated by McDonald's Australia Limited.
Grant amount	The total maximum available for all grants for each Round is \$30,000. The Panel will determine the amount and number of the grants awarded (if any) for each Round.
Notification to successful applicant	The successful applicants' details will be published within 4 weeks of the end of each Application Period on the McDonald's website. All successful applicants will also be notified by email.

MACCA'S JUNIOR SPORTS GRANT

CONDITIONS OF GRANT

1. Eligible Applicants may apply for a Grant during the Application Period in accordance with the Application Method. If an authorized representative of an Eligible Applicant who is under 18 years of age wishes to apply, parental consent must be provided. Eligible Applicants must provide all information required to apply for the Grant.
2. Multiple applications are permitted, however, each application must be substantially unique and submitted separately and must independently comply with these Conditions.
3. Applications are deemed accepted at the time of receipt, and not the time of transmission. McDonald's accepts no responsibility for late, lost or misdirected applications. Incomplete or incorrect application will be deemed invalid.
4. The decision by McDonald's to accept or reject an application is in McDonald's sole discretion and no correspondence will be entered into. Applications that seek any of the following will not be deemed a valid application and will be disqualified:
 - a. retrospective costs
 - b. projects outside the designated geographical zone of regional Western Australia
 - c. general fundraising appeals
 - d. travel to and from sporting competitions or related events
 - e. technological devices and software
 - f. funding for coaching or umpiring related activities
 - g. fixed assets and construction of or improvements to buildings or infrastructure, such as Clubhouses, or amenities
 - h. non-sporting equipment; and
 - i. venue hire, membership, or other operational fees.
5. Any application that contains content that McDonald's, in its sole discretion, considers to be offensive, obscene, crude or inappropriate in any way or that McDonald's considers may infringe any intellectual property rights or other rights of any person, corporation or entity will not be accepted as an eligible application into the Grant.

McDonald's reserves the right to verify the validity of any and all entries and to disqualify any Eligible Applicant for: (a) tampering with the entry process; (b) submitting an entry which is not in accordance with these Conditions; or (c) engaging in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Grant. McDonald's legal rights to recover damages or other compensation from such an offender are reserved. A Grant will only be awarded following any winner validation and verification that the McDonald's or its agents require in their absolute discretion.
11. If the Grant or a Round is not capable of running as planned, McDonald's reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Grant or Round.
12. McDonald's, its franchisees (if applicable) and its associated agencies and companies exclude all liability (including negligence) except for any liability that cannot be excluded by law (including any applicable Consumer Guarantee under the Consumer Laws), for any direct or indirect injury, loss and/or damage arising in any way out of the Grant. This includes, but is not limited to: (i) technical malfunctions, delays or failures, including those resulting from accessing any materials related to this Grant and any incorrect, inaccurate or incomplete information communicated in the course of, or in connection with, this Grant as a result of any technical malfunctions, delays or failures; (ii) lost or damaged entries; and/or (iv) acceptance and/or use of any Grant.

As a condition of applying for the Grant, an Eligible Applicant (and parental consent, if required) consents to, in the event they are a winner, McDonald's using the Eligible Applicant's entry, name, locality, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period of time without further notification, remuneration or compensation for the purpose of promoting, publicising or marketing the Grant (including any outcome), and/or promoting any products or services manufactured, distributed and/or supplied by McDonald's.
